Thank you for your request for information about The Charnwood u3a. We are a local organisation run by our members, for our members. We are a learning co-operative, responsible for our own programme and finance. Membership is open to all who are retired or semi-retired. We rely on the involvement of our members to organise and carry out the programme.

We are affiliated to a national organisation – the Third Age Trust – which provides insurance, advice, information and links to other u3a groups. More information about this national organisation is available at www.u3a.org.uk.

Our main activities take place in groups which reflect the members' interests. The groups are small and informal; no qualifications are needed to join. Each group is self-funding and there may be an additional charge to cover running costs such as room hire, transport costs and speaker fees. Most groups are able to accept new members although some may be full. Extra groups can be set up where members are willing to start them – help to do this is always available.

There is a monthly members' meeting, on the second Wednesday of each month (except July), organised by the committee. At each meeting, we have a speaker or some other activity and a chance to meet other members over a cup of tea. You are welcome to attend one of these meetings before joining the u3a.
